

How are you, I hope well. I Just got the post card that your Firm has aquired a new member or Associate, glad that things are looking up for you. Its been seven months now since we went to P.C.R. Court, have you heard anything is of yet? Also, since we saw each other I've had some major Health issues that have happened; I've lost my hearing in my right Ear due to negligence and two months ago had something happen when I passed out coming out of the shower. Still have not seen a Doctor to this day. I had lost all movement on my left side and was in a really bad condition, I was given one Blood pressure pill (blood pressure at time was 220-120) and Five tylenol and sent back to the dorm in an upstairs room, have been moved after 2 weeks of having to get someone to help me up and down stairs. Lost most of the vision in my left eye (got some back) AND still have many physical symptoms that have lingered since. I don't know if it was a stroke or Heart problem still numb in left side, and Headaches really Bad, Heart, left arm, and neck on left side stay in pain, at night its alot worse. I've pleaded with Staff here and my sister has called, but I still have not recieved any help. Can you help me, or do you know someone who could be interested in pursuing this. I really need a lawyer!

Most of all I need to see a specialist and have test to find out what's wrong with me.

This is something that happens here a lot, one man died on the other side of my dorm about a month ago, and another was refused help that the captain made them (medical) send to the Hospital and is still in Hospital (Roy Price) here in the Charleston area. I promise at least 15-20 people have died or were killed here in the past 3 years since I've been here. A lot due to medical negligence.

I wasn't going to do anything but they just refuse to help or anything. They say I've may go for a CT scan that's been over a month now. The doctor that's here Dr. Brynes is an OBGYN Doctor and is Dislexic. That's what His own staff told me. I'm in need of a Lawyer maybe you can help. I sure hope so
