



Did, within this County and State on the 1<sup>st</sup> day of December, 2021 violate the criminal laws of the State of South Carolina in the following particulars:

The affiant states that there is probable cause to believe that the defendant named above did commit the crime set forth and that such probable cause is based on the following facts:

That on December 1<sup>st</sup>, 2021, while near Dorchester Road and Oscar Johnson Boulevard, SC in the County and State aforesaid, the above named defendant, KENNETH ALLEN FULTON, did commit the offense of violation section 16-13-180 of the South Carolina State Code of Laws, 1976 as amended, **RECEIVING STOLEN GOODS \$10,000 OR MORE**, in that he did willfully and unlawfully have in his possession and under his control a white 2013 Mazda CX5 bearing South Carolina Tag: NHD971, with a vehicle identification number: JM3KE4BE8D0152065 which was reported stolen by Oded Rosales to the North Charleston Police Department on November 28th, 2021. The approximate value of the vehicle is \$16,000.

That on December 1<sup>st</sup>, 2021, Deputy Buller received an automated license plate reader (ALPR) alert for a stolen white 2013 Mazda CX5 (SC: NHD971), traveling on Dorchester Road. Deputy Buller located the vehicle and verified through dispatch the Mazda was still reported stolen. A traffic stop was attempted on I-526 eastbound near Rivers Avenue but the vehicle accelerated away and a vehicle pursuit was initiated through North Charleston, Mount Pleasant, City of Charleston and back into North Charleston where it ended in the Lake Ashley Mobile Home Park. The defendant fled from the vehicle on foot and was taken into custody following a foot pursuit. Post miranda the defendant was unable to say who the vehicle belonged to or provide a reason he ran from the police. The 10 minute hit was sent to NCPD and confirmed a short time later (NIC#: V403480120). The vehicle was valued at approximately \$16,000 after reviewing similar vehicles listed for sale on CarMax.

Deputy T. Buller is witness to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.

The affiant states that there is probable cause to believe that the defendant named above did commit the crime set forth and that such probable cause is based on the following facts:

That on December 1<sup>st</sup>, 2021 at approximately 0221 hours, while near Dorchester Road and Oscar Johnson Boulevard, SC in the County and State aforesaid, the above named defendant, KENNETH ALLEN FULTON, did commit the offense of violation section 56-5-750 of the South Carolina State Code of Laws, 1976 as amended, **FAILURE TO STOP FOR BLUE LIGHTS**, in that he did willfully and unlawfully fail to stop the motor vehicle for a law enforcement officer when signaled by blue lights and sirens.

On December 1<sup>st</sup>, 2021, Deputy Buller of the Charleston County Sheriff's Office attempted a traffic stop on a white 2013 Mazda CX5 (SC: NHD971) that was reported stolen with the North Charleston Police Department. The Mazda failed to stop for blue lights and sirens and clearly attempted to elude law enforcement as it accelerated away on I-526 eastbound. A pursuit ensued through North Charleston, Mount Pleasant, City of Charleston and back into North Charleston. The pursuit ended when the defendant fled on foot from the vehicle in the Lake Ashley Mobile Home Park of Dorchester Road. After a foot pursuit the defendant was taken into custody.

Deputy Buller is witness to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.




