Instruction

The Walk & Turn Test

- Cannot keep balance while balancing to instructions
- Starts before instructions are finished
- Stops walking to steady self
- Does not touch heel to toe
- Loses balance while walking **Stops off the line**
- Uses arms for balance while walking
- (raises arms over six inches)
- Loses balance while turning; turns incorrectly
- Incorrect number of steps
- Suspect cannot perform the test

One-Leg Stand Test

- Sways while balancing
- Uses arms to balance (raises arms over six inches)
- Hopping
- Puts foot down
- Suspect cannot perform the test (puts foot down 3 times)
