

TRANSCRIPTS (*if necessary*)**

A transcript has already been obtained for the September 28, 2020 evidentiary hearing held before the South Carolina Workers Compensation Commission ("SCWCC") (the Order from this hearing was entered by the SCWCC May 13, 2021 was submitted in connection with this appeal). Respondents appealed this May 13, 2021 Order of the SCWCC and another, brief, hearing was held via Zoom on August 30, 2021. After this brief hearing and the SCWCC's review of the record at hand in the case the Order from the August 20, 2021 was entered by the SCWCC on December 21, 2021 (this Order was also submitted in connection with this appeal).
