

3. Self Addressed stamped envelope.

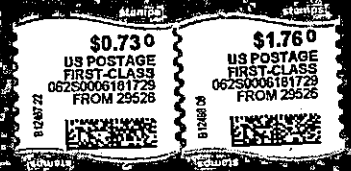
