It was affirmed by this Honorable Court, holding that the ALC correctly concluded it lacked authority or jurisdiction to determine whether SCDC violated the South Carolina Constitution quoting SC Department of Corrections v. Cartrette, 387 S.C. 640, 649 S.E.2d 18, 23 (Ct. App 2010) concluding

deductions from an inmate's pay for room and board did not violate the state's obligation under article XII section 2 of the state constitution to "provide for the custody, maintenance, health, welfare, education, and rehabilitation of its inmates."

For this reason, that this matter does not involve an inmate's pay. Appellant, respectfully asks for Rehearing En Banc, to determine whether SCDC violated the State's Constitution and the U.S. Constitution 14th Amend Section 1., where the Appellant's rights were being infringed upon to take his protected personal property by an state created liberty interest. SC. Code 14-8-200, where Court of Appeals has jurisdiction (Supp 2016).

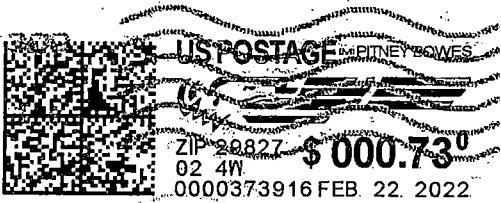
