
I am enclosing herewith a Notice of Appeal, Interlocutory Order of the Honorable John C. Hayes, III, Certificate of Mailing and a check in the amount of \$100.00.

A Motion Hearing was held on April 23, 2013 before the Honorable John C. Hayes, III whereby the Defendants/Appellant's sought a stay due to non-compliance of the Plaintiff/Respondent with the South Carolina Notice and Opportunity to Cure Construction Dwelling Defect Act. This motion was denied and an interlocutory order was issued.

It is Appellants position that denial of their motion to stay the proceedings until the Plaintiff/Respondent complied with the Act is an error of law. Although this is an interlocutory order, it is the Appellant's position that denial of their motion affects a substantial right, including their ability to exercise their rights under S.C. Code §40-59-850 as well as prevents an appeal on this ground at the conclusion of the action.


