
Dear Ms. Kitchings,

This matter is a cross-appeal, and both Records on Appeal are due on or before Monday, February 21, 2022. I am writing to request a two-week extension for both parties. The reason for the request is that I encountered technical difficulties in retrieving a few of the designated digital records, which means we either are going to have to file a Record on Appeal followed by a Supplemental Record on Appeal, or, assuming we can recover the missing digital records, request an extension. (The Record is nearly complete, but several designations of digital records cannot presently be located, even though it is possible we will overcome this technical difficulty in time to meet the February 21st deadline.) I conferred with opposing counsel prior to making this request, and he does not oppose it.
