ORDER

Appellant has filed a motion to amend the caption to properly reflect Taschner Textiles Industries, LLC as a Respondent in this appeal in lieu of City Electric Supply Company. The order on appeal granted summary judgment in favor of Taschner Textiles Industries, LLC, and specifically noted it was not ruling on the motion filed by City Electric Supply Company. Therefore, the designation of City Electric Supply Company as a Respondent was a mere clerical error. *See Weatherford v. Price*, 340 S.C. 572, 577-78, 532 S.E.2d 310, 313 (Ct. App. 2000) (finding this Court has jurisdiction to hear an appeal when appellant's failure to technically appeal the proper order was of a clerical nature only). Accordingly, the motion to amend is granted.
