**MOTION FOR COSTS**



See Rule 222 (a), SCACR ("[C]osts shall be taxed against the appellant when the appeal is dismissed or judgment on appeal is affirmed.") This Motion is accompanied by a sworn, itemized statement of costs, as required by Rule 222(d), SCACR.

The basis for this Motion is that on February 9, 2022, this Court dismissed Appellants' appeal from the circuit court's order dated October 22, 2019, because the circuit court's order is not immediately appealable. See S.C. Code Ann. § 15-48-200;


