**RETURN TO RESPONDENT'S MOTION FOR
TAXATION OF COSTS AGAINST THE APPELLANT**

This matter comes before the Court pursuant to the Respondent's Motion for Taxation of Costs against the Appellant. Appellant argues that the Respondent is not entitled to an award of Attorney's fees against the Appellant.

The first step is to determine whether a party is entitled to fees. In deciding whether to award attorney's fees and costs the court shall consider the following factors to determine the amount of fee that should be awarded: (1) the nature, extent, and difficulty of the case; (2) the time necessarily devoted to the case; (3) professional standing of counsel; (4) contingency of compensation; (5) beneficial results obtained; and (6) customary legal fees for similar services. *Glasscock v. Glasscock*, 304 S.C. 158, 161, 403 S.E.2d 313, 315 (1991). Respondant did not

provide proof of attorney's fees charged or paid or an attorney fee affidavit in support of its Motion for costs or any basis upon which the Court can consider the Glasscock factors.

Appellant is informed and believes the Respondent is not entitled to an award of attorney's fees.
