





This matter came before me on motion of Carl B. Grant, Esquire, in my virtual courtroom on March 24, 2021. Attending the hearing virtually were Hugh Ryan, Esquire, Director of SCCID, and Hervery Young, Esquire, General Counsel of SCCID. Mr. Grant provided the court, SCCID, and the Solicitor with a copy of his most recent motion to be relieved as counsel. After hearing the discussions of counsel on the issue of Mr. Grant seeking to be relieved this Court makes the following findings of facts:

1. When Mr. Grant was appointed on April 4, 2017, there was a contract attorney system provided by SCCID.
2. The contract attorneys for Orangeburg County were not available for appointment on April 4, 2017.
3. Procedurally, the Supreme Court provides that if contract attorneys are not available for that county, will attempt to provide the name of another contract attorney to handle

the matter. If no contract attorney is available than an attorney shall be appointed from the county's Rule 608 list. SCCID was not contacted, and Mr. Grant was appointed pursuant to Rule 608 to represent the Defendant.

4. Pursuant to Rule 608 (d) (1) (G) since Mr. Grant has been admitted to practice law in this state for at least thirty years, he is now exempt from being appointed to serve as counsel or guardian ad litem for persons in the circuit or family courts. Therefore, Mr. Grant could have asserted this exemption at the time of his initial appointment if he desired.

5. Mr. Grant has two offices, one in Orangeburg and the other in Columbia, South Carolina.

6. As a sole practitioner, Mr. Grant is the only financial provider for his business and household.

7. Mr. Grant's office staff has decreased from five full time personnel to presently only having one employee to assist with administrative and daily operations, and case preparation in both offices.

8. Mr. Grant's handling of this case will result in an unreasonable financial burden on Mr. Grant and his law firm.

9. The unreasonable financial burden upon Mr. Grant is exacerbated by the effects of the economy that is restrained by a global pandemic that has detrimentally impacted many small businesses, including The Law Firm of Carl B. Grant, P.A.

10. Mr. Grant being relieved from this case will not have a material effect on the Defendant.

11. The Defendant has consented to Mr. Grant being relieved as his attorney. See Defendant's Consent dated March 24, 2021, attached hereto.



ACCORDINGLY, IT IS HEREBY ORDERED that Carl B. Grant, Esq. is relieved as counsel for Antly J. Scott and that Ola Johnson, Esq. is hereby appointed as his attorney and on his behalf. Therefore, Mr. Grant's motions filed with this court on March 19, 2021 and February 26, 2021 are now moot. The Court requests that Mr. Grant forward a copy of the Defendants' file to Mr. Johnson.
