APPELLANT'S MOTION FOR REINSTATEMENT OF
APPEAL AND LEAVE FOR LATE FILING

Counsel for Appellant hereby submits a Motion for an Order of Reinstatement of the Appeal and leave for late filing of Appellant's Initial Brief pursuant to South Carolina Appellate Court Rule 260(a) and states to the Court the following:

On December 29, 2021, Appellant timely filed a Notice of Appeal with his Honorable Court, pro se (see Exhibit A). On January 10, 2022, this Honorable Court sent a letter to Appellant requesting his attorney's name and the name of the personal representative of James Washington's Estate (see Exhibit B). Appellant timely responded that he is in the process of hiring an attorney for both the Appeal and the personal representative appointment (see Exhibit C). During this time, Appellant was gathering the funds for those services. Appellant was able to do so on February 24, 2022. On February 28, 2022 Appellant's Counsel sent a Notice of Appearance to; Attorney for

Respondent, David Chard, Esquire at 2050 Spaulding Drive, Suite 2, North Charleston, SC 29406; Mark Weeks, Esquire, at Weeks & Irvine, 8086-B Rivers Avenue, North Charleston, SC 29406; the Clerk of Court for Berkeley County Master in Equity at P.O. Box 609, Moncks Corner, SC 29461; and Clerk of Court, South Carolina Court of Appeals at P.O. Box 11629, Columbia, SC 29211 on February 28, 2022 (see Exhibit D). A copy was mailed to all recipients and emailed to both attorneys on record (see Exhibit E). There was a scrivener's error on the Notice of Appearance and correspondence, naming the Appellant as "Keith" instead of "Kenneth". The same date, an Order of Dismissal was filed on behalf of the South Carolina Court of Appeal, unbeknownst to Appellant or his Counsel until March 3, 2021 (see Exhibit F).

Appellant's Counsel has already begun the Appellant's Brief and has dedicated time towards this case. The Curry Law Firm, LLC is currently working on getting James Washington's Estate reopened so that Kenneth Washington can be appointed as personal representative.

In the lower court, the Appellant, an heir of James Washington's Estate, was never served with the Summons and Complaint and was not put on notice of any hearing but the last hearing which the lower court rendered their judgment. The Appellant has felt that he has missed a fair opportunity to be heard because the lower court entered judgment against him and the estate, leading to a deprivation of his due process.

The Appellant believes that the reinstatement of the Appeal would not be a disadvantage to any of the parties as the Notice of Appearance was served on Respondents and Appellant can move forward, ensuring that all filing deadlines are met.

Further, Appellant's counsel intends to file their Initial Brief within the next twenty-seven (27) days, as required by South Carolina Rule 208.

Pursuant to South Carolina Appellate Court Rule 260(a), this motion is being filed within fifteen (15) days of the dismissal notice.

WHEREFORE, Appellant is respectfully requesting this Court reinstate the appeal and grant the Appellants leave for late filing of Appellant's Initial Brief.




