ORDER

This matter is before the South Carolina Administrative Law Court (Court or ALC) pursuant to an appeal filed by Walter McQuine (Appellant), an inmate housed in the South Carolina Department of Corrections (Department or SCDC).

On September 20, 2021, Appellant filed this appeal involving inmate wages. The Department filed the Record on Appeal on December 1, 2021. Then, on January 19, 2022, the Department filed a Motion to Hold in Abeyance (Motion) asking the Court to hold this case in abeyance because there is a case awaiting certiorari from the South Carolina Supreme Court (Supreme Court) addressing the same issue presented in this case: *Torrence v. S.C. Dep't of Corr.*, 433 S.C. 633, 861 S.E.2d 36 (Ct. App. 2021), *reh'g denied* (Aug. 4, 2021). Appellant objected to the Motion.

I find that if the Supreme Court denies certiorari, the South Carolina Court of Appeals' existing decision could resolve the issue at hand. Accordingly,

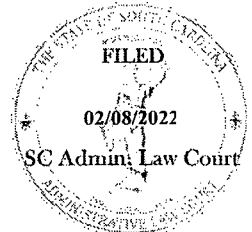

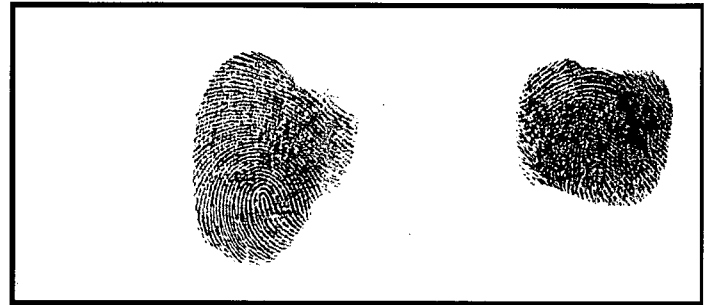
