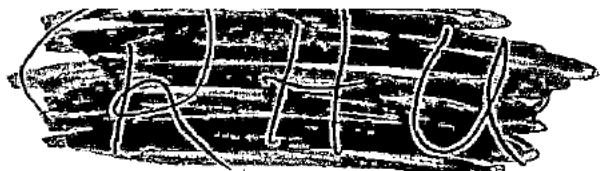

This memo is in Reference to what is Allowed to be Copied in the Institutions Law Library as Legal Copies. There will be No Exceptions to this portion of the Policy. We have been having too many cases of the Population Not Knowing what can be copied.

S.C.D.C. POLICY GA - 01.03 ACCESS TO COURTS

SECTION 12.2 MATERIALS AND DOCUMENTS THAT WILL NOT BE COPIED INCLUDE:

- Inmates may not purchase photocopies of any reference materials contained in Law Library regardless of his/her ability to pay.
- Drawings, Pictures, Photographs;
- Documents that have been solely originated, generated, written, typed, or created by an inmate (the inmate may copy this information by hand)
- **NOTE:** The Fact that a Document solely generated by an inmate has been *Notarized* does Not Mandate that photocopies be provided;
- Transcripts of School, College, or Vocational Training;
- Magazines or Newspaper Clippings (Unless they Specifically Relate to the Pleading);
- Personal Correspondence that is Not Related to the Pleading;
- Copies of S.C.D.C. Policies; and
- Copies of Case Law.

~~NOTE: If the Librarian is Unsure about Whether or Not a Copy Should be Made, s/he should request Assistance from the Office of General Counsel. (4 - 4276)~~

~~Please Pay Close Attention to the Section about Hand-Generated Documents because this is the Most Misunderstood Part of the Policy. This Means that Any hand-Written or Typed Papers Done by the Inmate CAN NOT and WILL NOT be copied for any reason(s). You will have To Write or Type any Extra Copies of these Types of Documents. There Will be NO Exceptions to this Policy.~~
