

BRIEF OF CLAIMANT/RESPONDENTS  
1/14/2021

First of all, I want to say that I mailed my brief off December 16,2021. The commission received it on December 21,2021. My understanding is the defendants has ten days to respond. I received the response from the defendants on January 10,2021. Then received an amended response on January 15,2021. My point is the defendants were over the ten days allowed for a response. I was not allowed to respond after the ten days when the motion to compel was sent in. Thomas Phillips was still representing me at the time the motion to compel was sent in. Thomas Phillips never responded to the motion to compel nor did he tell me to. Thomas Phillips never responded to the form 21 and he was still representing me at the time nor did he tell me that I needed to respond within ten days on either one. The claim Wcc file no. 1421297 is my right knee. I did not receive treatment by all the doctor's the defendants has listed. I saw Doctor Grady, who the defendants sent me to and was under his care for over a year. Then the defendants sent me to Doctor Hoenig, which I seen him all of fifteen minutes and he placed me at MMI within fifteen minutes. We had a hearing May or June of 2016. Which at that time the defendants withdrew their form to the hearing and wanted time to get a Deposition from Doctor Hoenig. So, the defendants caused a delay not me. We at that time had not made any agreements to settle. The defendants keeps saying I wanted to withdraw from the first settlement and that is simple not true and can be proven. The First settlement went on record in May of 2017 and June 2017, I signed the agreement. We didn't have a settlement until May of 2017. From when Doctor Hoenig placed me at MMI 2016 and we went to the hearing were the defendants withdrew there form and wanted time to get a deposition from him. Doctor Hoenig couldn't give them a deposition until December of 2016. So, the defendants keep delaying not me nor did I have a settlement the first time that I tried to get out of. Doctor Hoenig had recommended that I needed knee injections and lidocaine patches. The defendants keeps delaying treatment for those. Before we went to the hearing in May 2017, I couldn't get the defendants to give me that treatment. I tried to go back to Doctor Hoenig for treatment due to pain. Doctor Hoenig said that he only did a evaluation and that he wasn't going to treat me. So, it is my right to go to another doctor and which I paid out of my pocket for. I wanted a second opinion, I went to see Doctor Sanchez. He wanted me to see his partner Doctor Leong for his opinion. Doctor Leong did treat me and placed me at MMI on 2019. I was having issues the whole time after surgery. Doctor Leong also said that less than 6 months later I would need hardware surgery. Doctor Leong then releases me and said if I wanted to come back to him for hardware surgery I could but didn't have to. Cause he was leaving that practice. So, at that time Charlie Hodge was my lawyer. The defendants sent in for a hearing. Charlie and I talked that I wanted to go in front of the commissioner and didn't want to settle. The hearing was the next day and at that time also Thomas Phillips was my lawyer for the sexual harassment claim. Charlie blindsided me and told me this is what is going to happen like I had no choice in it. Charlie told me that I would have one year to reopen the case and they were paying me an extra 5% rating. I was confused and told him I don't understand and Charlie Hodge said well this is the law. JoJo Wilson was a witness to this also. So, we rush into the hearing and I am very confused. So, the day after I did voice my withdraw with Charlie Hodge. So, then Charlie Hodge withdrew like a month or so after the hearing. When I was able to retain another lawyer, I did retain Thomas Phillips who was already representing me at that time with the sexual harassment claim, that was in July. I had went and seen two doctor's out of my pocket. I seen Doctor Kana in June 2019, and then see Doctor Wyland in August 2019. The defendants then wanted me to come in to do another deposition in October of 2019. Which was only suppose to be for my knee claim then in the middle of the deposition she switch and wanted to talk about the sexual harassment claim. She tries to combine both claims together and I told her they are separate claims. In this deposition I was ask if I wanted to settle and I said no. Motion to compel hearing was set for November 2019. At that time the defendants agreed to paid for the hardware surgery and agreed to find a doctor to do the surgery that we both agree to or we would come back in front of the commissioner and let the commissioner decide. I have waited now over years now for a surgery and now my knee is in worse shape due to the delay of treatment. I have not seen every orthopedic doctor's in the upstate as to there are over 30 in Spartanburg, over a 100 in Greenville among other cities in the upstate. I have not alienated my self with anyone. Doctor Hoenig never treated me and Leong said he wanted me to be comfortable with my treatment. Colbath never did anything and said to use

conservative treatment. As, I went to his partner Doctor Phillips that said other wise. I went to him after having to go to hospital for pain and insability due to defendants delaying treatment for over 2 years now. I did sign the second agreement as my lawyer Thomas Phillips said that was the best option since they were going to agree to do my surgery. Thomas Phillips filed a knee hearing due to not having a doctor and no treatment in over nine months. After, I had been paying out of my pocket to see my PCP for medication for the sexual harassment claim. Doctor Holland couldn't write any medication. The defendants then sent me to another Doctor in Columbia SC, 136 miles one way for evaluation from Dr. Riley. Dr Riley then recommends me for treatment and medication. The defendants did not provide me with any treatment after they sent me to the Doctor. I guess cause they didn't like his evaluation. So, when Thomas filed for a hearing then I received notice to see Dr. Compean in Feb 2020. I saw her three times before this mediation that I never ask for. Dr. Compean said after a 12 week therapy sessions which she was setting up, that I never attended. The nurse case manager ask when she thought I would be at MMI. Dr. Compean said we can evaluate her after the 12 week therapy. She didn't say I would be at MMI by then or not. The Mandatory mediation is only when I am at MMI. I was not at MMI. Thomas Phillips then states that the commissioner signed off saying we had to go to mediation. Thomas Phillips also stated that this mediation was only for the mental claim. I stated at the mediation that I was forced here and shouldn't be due to my mental state. I also stated at the mediation that this was only suppose to be for the mental claim. I also never agreed to talk about my knee claim. Which all were aware of my anxiety and mental shape before mediation took place. I was in a stressful long day mediation with anxiety and panic attacks trying to understand something is very hard to concentrate, hard to stay focused. The form 70 is incorrect. Thomas Phillips voiced he was filing to withdrawal for counsel. Thomas Phillips filed for withdrawal of counsel on May 6, 2020 and then again on May 12, 2020 and then again on May 15,2020. On May 11, 2020 defendants filed motion to compel and filed a form 21. Thomas Phillips was still representing me at this time and he never responded back to either one nor did he tell me that I needed to and that I had ten days to do it. I couldn't retain counsel until Thomas Phillips was released. Commissioner Scott Beck granted relieve of counsel on the 1717574 mental claim only. Commissioner Melody James granted relieve of counsel on the 1421297 on May 30, 2020. Then a hearing was set on June 16, 2020. I then requested to retain counsel. I ask if I could respond to the motion to compel and was told by email that I only had ten days after it was filed. I also wrote asking if I needed to do anything and no one told me that I needed to response. The motion to compel and form 21 were set before two different commissioner's. Commissioner Melody James gave me 30 days to retain counsel. The motion to compel was never reset. On July 23,2020 was set for the form 21. Commissioner Wilkerson said he couldn't hold the hearing. Then on August 10, 2020 it was sent to be set to the next commissioner. I wrote in to ask to make sure that I never got to tell my side of the story. A hearing was never reset. Commissioner Mike Campbell just made the decision to grant the motion to compel. Commissioner Mike Campbell denied the motion to compel for my surgery. I don't know why she sent the checks to Thomas Phillips or (if she did) after he said he was filing for release of counsel. He had already filed to be released. I also had seven days to withdraw from the employment release of all claims, which I did that.

The claim 1717574 mental claim. I want to address somethings the defendants are saying. I was not given the chance to ever tell my side and what all happen due to the Vice president of our company. I did not give her permission to take photos of my phone of text messages. I did tell her she could look. I was never given any information about the investigation done by the company. I was told that I couldn't have that information. I was never told that I was willing participant in this. Which the company did an investigation and so did the lady from worker's comp. The lady from worker's comp talked to my co-worker who saw how my supervisor would act towards me. I was never told by neither I was a willing participant. My supervisor/stalker touched me many times. He locked me in the office. Along many other things but no one gave me a chance to tell them everything. I was treated horrible by my company when my co-worker called the home office. I couldn't make any progress in therapy due to not having the right medications and being harassed by co-worker's, supervisor's, and upper management. Thomas Phillips did misrepresent me if he lied to me about a commissioner saying I had to go to the mediation. I don't care how much education I have when someone is under stress, anxiety, panic attacks no one can make a sound mind decision. I did let dr. Compean and nurse case manager that I was having anxiety and panic attacks due to being forced into mediation while I am still under doctor's care. Derrick Williams left after we signed the form 70. So, he was not in there when the paperwork was being gone over. Which that is the only thing that is suppose to be signed in mediation is the form 70.

I feel that I was not represented by an lawyer due to him mis represented me. I was still under doctor's care and still in no mental shape to make a legal decision.



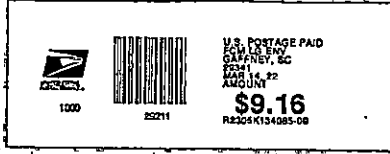
