MOTION FOR EXTENSION OF TIME TO FILE APPELLANT'S INITIAL BRIEF AND DESIGNATION OF MATTER TO BE INCLUDED IN THE RECORD ON APPEAL

1. Counsel for Appellant recently advised the Court that the Transcripts in this matter were ordered and received prior to the filing of this appeal; however, Counsel's office inadvertently failed to properly calendar relevant deadlines for perfecting the appeal based on having previously ordered and received the transcripts. Due to this inadvertence, the time for filing the Appellant's initial brief has passed without having been properly calendared within Counsel's office.
2. In addition, Counsel for the Appellant has experienced a heavy work load over the past several weeks, to include preparations for a multi-day jury trial, which, particularly in light of Counsel's status as a solo practitioner, has involved a far greater time commitment than originally anticipated and has interrupted Counsel's ability to complete the initial brief.
3. Counsel for Appellants therefore requests an extension of time to file the Appellant's Initial Brief and Designation of Matter to be Included in the Record on Appeal until April 8, 2022.
4. This is Appellant's first motion for an extension of time with respect to filing the Appellant's Initial Brief, although the initial inadvertence concerning the status of transcripts resulted in a miscalculation of the initial due date.
5. This motion is not being made for purposes of delay; rather, Counsel's initial inadvertent calendaring error and heavy workload have necessitated this request.
6. Counsel for Appellant further requests that all deadlines relevant to perfecting the appeal in this matter be held in abeyance pending the Court's ruling on this motion.

Accordingly, Appellant requests an extension of time until April, 8 2022 to file and serve the Appellant's Initial Brief.
