I TOLD THE JUDGE GRAFFON THAT I DONT EVEN AGREE WITH MY PUBLIC DEFENDERS LINE OF DEFENSE AND HE WOULDN'T MAKE THE ARGUMENT I WANTED HIM TO MAKE. ALL THIS IS ON RECORD. I WASN'T GIVEN A CHANCE AT A FAIR TRIAL. I CHOOSE MY ARGUMENT TO MY LIFE & TRIAL.

IN SEVERAL COURT APPEARANCES TO FIRE MY PUBLIC DEFENDER PRIOR TO MY TRIAL, ASK FOR A CONTINUANCE & I SPENT \$10,000 ON A NEW LAWYER WHO WHEN HE WASN'T GIVEN A CHANCE TO PREPARE FOR MY CASE, THE LOCAL COURTS IN AZICAN COUNTY DID ME VERY WRONG AND I WANT TO HAVE A CHANCE AT A FAIR TRIAL.

I WENT FROM NOT EVEN KNOWING ABOUT MAKING A TRIAL, ON DEC 28th²⁰²¹ FOUND OUT I WAS ON THE DOCKET TO TRIAL ON FEB 14th 2022. THE WHOLE TIME IN TRYING TO FIRE MY PUBLIC DEFENDER & GET A GOOD LAWYER, BARRY THOMPSON WOULDN'T ARGUE WHAT I WANTED PERIOD.
