
A couple of notes for my edification respectfully: First, neither I nor my assistant, Shery Smith, received an email on January 31, 2022, regarding the Court's Order of that same date. We have both reviewed our email for this Order and did not locate it. This is important to me as an officer of the Court for the Court to know that I would not, under any circumstances, ignore an Order from this or any other Court.

Second, upon a review of the file, I noticed that, on the Final Order of January 8, 2020, the name of the court reporter, Kathleen Owens-Hays, is listed on the first page. Accordingly, Ms. Myers either overlooked this or deliberately misled this Court regarding her inability to determine the identity of the court reporter.

My office has been informed by Doris Tompkins Brown, CVR, the court reporter present for the April 20, 2020 hearing, that Ms. Myers initiated contact with her, Ms. Brown, on Wednesday, November 24, 2021, from telephone number 803-757-5155. After speaking with Ms. Myers, and ascertaining what Ms. Myers was requesting, responded to Ms. Myers on Tuesday, November 30, 2020, via text, with detailed instructions on how to obtain the transcript of the Motions hearing. As of the writing of this letter, Ms. Brown has not received a reply requesting said transcript.

It is my hope that this letter will clarify the matter for the Court. Please contact me immediately if you require anything further from my office.


