My name is Jackie Childers and I was advised by Geoffrey M. Dunn who was the Attorney on my case in York County that he filed for the Appeal on my case and that I would need to contact your office on reason for me wanting a Appeal, so that's what I'm doing in this letter. There were a lot of shady and illegal things going on in the case that Mr. Dunn did nothing about and things that Mr. Dunn refused to do that violated my rights. To start off with the crime that happened wasn't planned and wasn't suppose to happen and only did cause I had the wrong person in my car which was Travis Baxter. The Sheriff's Dept and Solicitor Matthew Shelton told the media and the newspaper that the victims were badly beaten, but they weren't and refused medical attention and had no marks. They just wanted to make everything look worse than it was. At my first Bond hearing my life was threatened on video I made a police report and they covered it up. At my second bond hearing the Judge Hall who knows me and the victim's personally refused to remove himself cause of conflict of interest and I can prove by past transcripts were I've been in front of Judge Hall that he knows my whole family.

Also at that Bond hearing, they had a speaker for the victims come forward who is Magistrate Roy Long who knows the whole family and works in the same building as Judge Hall and Solicitor Shelton. This was totally illegal. Solicitor Shelton told whatever lies he could in front of a news camera at the Bond Hearing to make sure I didn't get a Bond and my Attorney Mr. Dunn allowed all this to take place. I asked Mr. Dunn several times which he ignored to file for a Change of Venue for my case to be tried in a different county cause I knew by all the shady stuff that was already going on I wouldn't get a fair trial. Mr. Dunn ignored to present my statement to the court on what really happened that night and ignored me several times to present evidence to the case that I had. Mr. Dunn wasn't trying to get charges reduced or dropped. It was plan that he was helping the Solicitor by keeping out anything that would help me. There's a lot that he ignored to do in order to help me in my case. Even my co-defendant stated I had no weapon and Solicitor Shelton admitted in court that only Travis Baxter had a weapon, but I was still charged with armed robbery, 1st Degree Burglary and Possession of a weapon and give 30 years in prison. Nobody cared if I was innocent as long as someone got sent to prison. This whole case was a frame up and very illegal.

When Mr. Dunn came to me with the 30 yr. plea the first time I told him no and asked what could he do for me at trial and his exact word were "oh you're gonna loose and get life". That told me that he wasn't on my side at all. Every time after that all he'd say on every visit is take the plea or get life in prison. I was even taken back in front of Judge Hall to be sentenced. The only reason I took the Alford vs M.C. plea is cause of all the shady stuff going on and saw that my Attorney wasn't gonna represent me right. I was thrown to the wolves without having all evidence presented in the case and a fair trial to prove my innocence. I just want a chance at a fair court to prove that what's being said is not true. If I was guilty I wouldn't be wasting my time or anyone else's I'd take my punishment like a man, but I'm not guilty and want someone to please do the right thing and help me please. There's a lot of other facts to this case that I'll inform a Attorney once given one. I ask that this letter be kept from the Solicitor and Mr. Dunn for the time being. I'm going to inform Mr. Dunn to release my statement to your office or the Attorney that I'm given. I didn't have a fighting chance in York County cause between Solicitor Shelton and Mr. Dunn they made sure that I could do nothing to help myself and I only took the plea cause I was told take the plea or get life. Please I want the right thing done.
