I am writing in response to your letter received by this office on January 18, 2022, in which you are requesting a copy of your transcript. If you would like to order a transcript of a proceeding that was heard in circuit or family courts, **for each hearing that you would like a transcript for**, you must complete the SCCA Form 800, Transcript Request Form, which I have included for your convenience.

To complete the Transcript Request Form, you will need the following information:

1. Case caption (i.e. State v. John Doe)
2. Name of presiding judge
3. County of proceeding
4. Date(s) of proceeding
5. Court reporter name, if available

Once you have completed the form, you may return it to this office or send it to the court reporter directly. Please note that there is no provision for court reporters to prepare and deliver transcripts at no cost to a party. Please refer to Rule 607 of the South Carolina Appellate Court Rules (SCACR), for the current fees charged to all parties for transcription services. Additionally, it is helpful to note that court reporters have sixty days to prepare a transcript once satisfactory payment arrangements have been made. They may also ask for up to four (4) 30-day extensions, if they are unable to complete the transcript by the initial deadline.

Once the court reporter receives your request, it will be processed pursuant to Rule 207 and 607 of the SCACR. Rule 607(h) governs the fees for transcripts, which are not provided for free or at reduced rates to any party. Please send by mail a money order or certified bank check to the court reporter in order to obtain the transcript. Some court reporters may accept personal checks. Please check with the court reporter to see if this option is available. Once your request is received, you will receive a copy of this form with the bottom portion completed. Please promptly submit your payment in order for the transcript to be provided. If you need to cancel the transcript request for any reason, you are responsible for paying for the pages of the transcript that have already been completed at the time of the cancellation.
