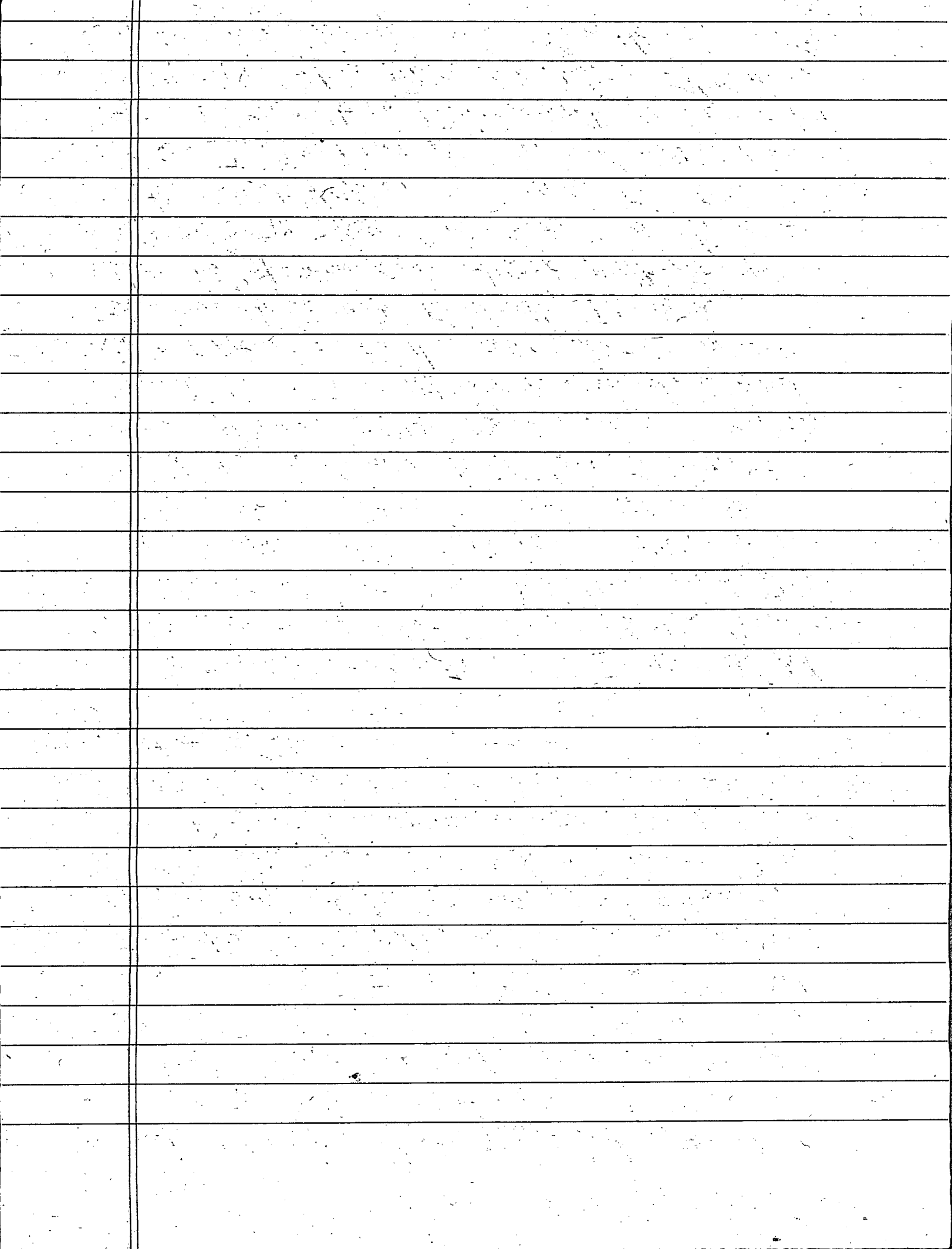

Dear Mr. Lee:

I received your letter dated February 6, 2013, requesting an arraignment transcript dated September 22, 2011, your trial transcripts, your complete defense file and your trial attorney's notes. You should have received your trial transcripts consisting of three volumes and dated March 12 - 14, 2012. I did not order your arraignment transcript and will not order it unless it is relevant to your direct appeal. If there was a motion made at your arraignment, for example a motion for a speedy trial or a motion to compel that was later renewed and ruled upon during your trial, I will order that transcript. At this point, I am not aware of any such motion.

I do not have what you refer to as your complete defense file. I do not have your trial attorney's notes. I have an indictment and an arrest warrant, the transcripts and I am waiting on receipt of letters that were introduced in evidence during your trial. I have not yet received a copy of the DVD of your statement.

Please understand that the only issues I can raise on direct appeal are issues that were raised at trial and ruled upon by the trial judge. Documents that were not introduced at trial can not be used on direct appeal. I can not request documents that are not relevant to your direct appeal.

Dear Mr. Lee:

I received your letter of March 24, 2013. You do not seem to remember a lot of things. I am going to try and explain them to you in this letter. I have already given you everything that I had. I gave that to you while I was representing you. You had copies of every single piece of discovery.

Your file probably contains between 250-400 pages of information that includes the photographs, incident reports, things like that. I do not feel like it is my place to copy that and then mail that to you. The postage alone will probably cost between \$20.00 and \$30.00. It will probably take over an hour to copy everything. If your mother wants to send me money to get my runner to pull the file, make copies of everything, I would be happy to do that.


If she would send me \$100.00, I think that would cover everything. I think that is being extremely reasonable.

I do not think that any case, statute, or Judge would require me to turn over my notes. I do not know what purpose that would serve you. Those are notes that I made when I was talking with you. Those are also notes that I made while we were in trial.

You have made several allegations in your letter that are untrue. Please do not threaten me in the future. Please do not tell me what I did or did not do that was right or wrong. You have your beliefs. I have my beliefs. I think that I tried an excellent case. I think that you had a legitimate chance to win. I think that your temper, the tone of your letters you wrote while in jail, as well as the way you handled all of these interviews sealed your fate. You are more than welcome to file a PCR against me. In the meantime, I will send a copy of this letter to your mother. If she wants to pay me, I will get everything out to you as quickly as possible.
