My Appellate Court Attorney refuses to order my Arraignment transcripts period and I desperately need them to Amend my "Anders-Brief" right now. I can not get my Appellate Attorney to send me a copy of my trial transcripts either. She says she sent them to me but I've never received any type of transcripts yet and she's saying she sent them months ago. My Appellate Attorney is Katharine Hudgins, Esq. I desperately need all transcripts or both these transcripts to do my "Anders-Brief" Sir, please help me.

Mr Shearouse I have a 45 day deadline on
Amending this "Anders-Brief". I can't do anything
to attend it without these transcripts along with
copies of all motions in my case. I've just written
to the Court of Appeals asking for a continuance
because for the last 45 days I've been trying
to get these two trial and Arraignment transcripts
but I can't get them from my Appellate Court
Attorney. I've written the Bar Assn., the Commission
on Lawyers Conduct, the Court of Appeal, the Court of
Administrations, the Chief Appellate Defender, Robert
Dudak and my own Appellate Attorney, Patricia Holgas
and for some reason nothing is being done about
getting me my transcripts. This is a major
hindrance to me trying to properly prepare my
Amendment to her "Anders-Brief" and then
again, what is going to happen if I can't get
the continuance, etc. I need help with every-
thing in this letter. Please sir. Please contact the

everyone it needs to go to. Please sir,

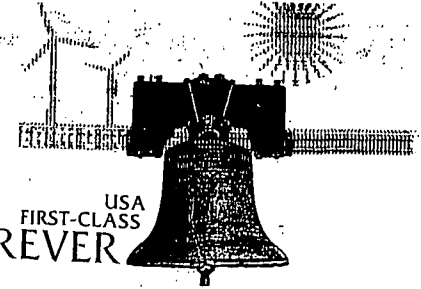
