MOTION FOR COSTS

Pursuant to Rule 242(j), SCACR, Respondent Jeanne Beverly, Individually and on behalf of others similarly situated, requests that the costs of this appeal be taxed against Petitioner Grand Strand Regional Medical Center, LLC, the respondent before the Court of Appeals. Rule 242(j)(1) provides that unless this Court orders otherwise, costs shall be assessed against the respondent before the Court of Appeals "[w]hen the decision of the Supreme Court has the effect of reversing the judgment of the lower court or tribunal which was on appeal." On February 23, 2022, this Court issued an opinion which had the effect of affirming the reversal of the circuit court's order dismissing Ms. Beverly's claims. Beverly v. Grand Strand Reg'l Med. Ctr., LLC, Op. No. 28084 (S.C. Sup. Ct. filed Feb. 23, 2022) (Howard Adv. Sh. No. 7 at 13). The Remittitur was issued on March 14, 2022. Because the Court has not ordered otherwise and because the parties have not agreed otherwise, Rule 242(j) provides the Court should award costs to Ms. Beverly.

Pursuant to Rule 242(j)(4), an itemized statement of costs is attached.
