





- 4) A Certificate of Filing (as to the filing of the Notice of Appeal and Proof of Service with the Spartanburg County Clerk of Court).

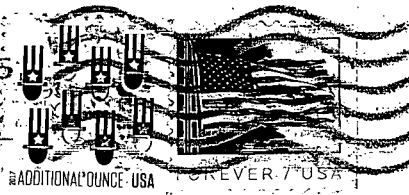
