MOTION FOR REHEARING

Appellant hereby moves this Court, pursuant to Rule 221, SCACR, to rehear and reconsider its March 16, 2022, Order granting costs to Appellant in the amount of \$2,562.20 pursuant to Rule 222, SCACR. Appellant hereby incorporates and reiterates all issues, arguments, and citations to authority raised to the Court in its February 11, 2022, Response to Respondent's Motion for Costs. The Court's order granting Appellant's motion made no ruling on any of the specific issues raised in Appellant's Response to Respondent's Motion for Costs, particularly:

1. This Court has discretion over whether to award fees and costs under Rule 222 and counsel for Respondent has made no argument as to why fees and costs should be awarded in this case. Therefore, Respondent has not met even the lowest of burdens to show why a Motion for Costs under Rule 222 should be granted. As a result, the Court should reconsider its order awarding fees and deny Respondent's Motion;
2. Counsel for Respondent has not shown that any fees or costs were actually incurred by Respondent and recovery under Rule 222 is limited to costs actually incurred in pursuing the appeal;
3. The Department had substantial justification for filing an appeal with this Court and the Department had strong legal justification for believing the appeal was not interlocutory. Therefore, it would be inequitable to tax the Department (a public agency) for costs and attorneys' fees. The Court should reconsider its order awarding fees and costs and deny Respondent's Motion for Costs; and
4. The issue upon which this Court based its decision to dismiss the Department's appeal in this case was neither raised nor argued by counsel for Respondent and this

Court should not tax the Department (a public agency) to reward Respondent for a winning argument that Respondent never made.

Because this Court has overlooked or misapprehended these issues, the Department respectfully requests the Court rehear this matter, reconsider its March 16, 2022, Order, and deny Respondent's Motion for Costs.
