
APPELLANT'S MOTION TO WITHDRAW APPEAL **SC Court of Appeals**

Appellant hereby moves, by and through his undersigned counsel, pursuant to Rule 260(c), SCACR, to withdraw the appeal of his conviction and sentence in the Court of General Sessions, Sumter County on September 23, 2011.

The below signed counsel was retained to represent the Appellant after trial counsel filed the Notice of Appeal in this case. By order of the South Carolina Court of Appeals, counsel for Appellant was substituted for counsel from the South Carolina Commission on Indigent Defense, Division of Appellate Defense. After review of the trial transcript and record of the below proceedings, Appellant moves to withdraw his appeal on the grounds that there are no appealable issues. Previously, this Court dismissed, pursuant to Anders v. California, 386 U.S. 738 (1967), the appeal of Appellant's trial co-defendant. See, State v. Kelley, Unpublished Op. No. 2012-UP-656

(S.C.Ct.App. filed Dec. 12, 2012). After consultation, Appellant moves to withdraw this appeal and pursue any potential issues related to his conviction and sentence through the post-conviction relief process.




