

To whom it may concern,

I am submitting material proof that the Spartanburg County, Court of General Sessions had no jurisdiction to accept my "As Indicted" Alford plea where no indictments existed. I am submitting copies of the Clerk of Court's records (case history) showing that no indictments existed or were clocked by the clerk of court, much less on 11/4/16 as the later produced documents purporting to be indictments claim.

I am also submitting a copy of the FBI's NCIC report form, detailing that only one "indictment" (2016-GS-420-5451) added after the fact (1/23/18) out of the four that were propagated by the prosecutor and eventually plead to, is even in their records. Again, being that the plea was "As Indicted", it is invalid where only one of the four indictments plead to appear anywhere in records.

Furthermore, when comparing the clerk's "stamp" on the later produced "indictments" that appear nowhere in records to the clerk's stamp on documents that appear in the clerk's records two days prior (Notice of Appearance) and months later (Return and Partial Motion to Dismiss), it is easily determined that the clerk's "stamp" itself on the so-called "indictments" are in fact forgeries. Such facts, especially considering that the "indictments" appear nowhere in records, proves that the "indictments" themselves are forgeries. The only legitimate marks on the "indictments" are the prosecutor's (Barry Barnette) signature.

South Carolina Rules of Criminal Procedure lays forth strict rules in regards to record keeping of documents including indictments. Considering the fact that no indictments appear anywhere in the clerk's case history and that only one later added indictment out of the claimed four even appears in the FBI's records, it is concluded that that the court did not have jurisdiction to accept an "as indicted" plea because no indictments existed, and especially where the (Alford) plea contained no admission of guilt. The plea is invalid.



## II. Allegations Raised and Relief Sought

In his application for post-conviction relief, Applicant alleges he is being held in custody unlawfully for the following reasons:

1. "Ineffective Assistance of Counsel"
  - a. "My motion of discovery was never viewed in its entirety by myself because I was not afforded the opportunity by my counselor."
  - b. "During the motion to suppress evidence, Mr. Nowicki never subpoenaed my witnesses to court so that the judge could evaluate their input into my argument that the arresting officer committed an illegal search prior to obtaining a search warrant."
2. "Illegal search and seizure"
  - a. "This was an illegal search as verified by court transcripts, even the judge admitted there was a violation but called it minimal."
3. "Miranda rights violation by arresting officer"

As requested relief, Applicant states he is seeking "for [his] conviction to be overturned on the grounds of illegal search and seizure and the Miranda rights violation or vacated on the grounds of ineffective assistance of counsel".
