On February 20, 2013, a final hearing was held to have Clay Massi evicted from my clients' condo located at 1100 Chandler Drive, Unit 101, Rock Hill, SC. Judge Kimball ruled in favor of my clients and ordered Mr. Massi to vacate the condo by March 20, 2013. Mr. Massi filed a motion to reconsider. At the motion hearing on March 11, 2013, Judge Kimball reiterated his prior ruling. Shortly thereafter, Mr. Massi filed an appeal. On March 25, 2013, Mr. Massi vacated the condo and no one has heard from him since. It is my understanding he made plans to move to Tennessee.
