**MOTION TO STAY APPELLATE DEADLINES AND TO REMAND TO THE
ADMINISTRATIVE LAW COURT**

Pursuant to Rules 240 and 241 of the South Carolina Appellate Court rules, Appellant St. Stephen’s Lutheran Church and Respondent Vision Ventures Investment Group, LLC d/b/a Navy Yard on Main, move to remand this matter for the purpose of allowing the Administrative Law Court (ALC) to consider a settlement—conditioned on the ALC’s incorporation of the agreement into an Amended Final Order—reached by the parties.

By way of background, this appeal was filed on January 20, 2022. Thereafter, Appellant and Respondent Vision Ventures reached an agreement that, if approved by the ALC and incorporated into an Amended Final Order, renders this appeal unnecessary. Following the ALC’s determination on whether to amend the Final Order, Appellant will immediately notify the Court

of the outcome in writing. Counsel for Appellant consulted with Counsel for Respondent South Carolina Department of Revenue (“DOR”) prior to filing this motion, and Counsel for DOR indicated that DOR does not oppose this Motion.

Accordingly, Appellant and Respondent Vision Ventures, without objection from DOR, respectfully request this Court stay all appellate deadlines and remand this matter to the ALC for consideration of the agreement and an Amended Final Order.
