Arguments frequently begin before the time set. Please ARRIVE 15 MINUTES prior to your scheduled argument time.





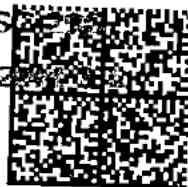
