

THE SOUTH CAROLINA COURT OF APPEALS,

I AM RESPECTFULLY REQUESTING A CONTINUANCE OR AN EXTENSION OF THE ALLOTTED TIME TO FILE A PRO SE APPELLATE BRIEF. I AM CURRENTLY REPRESENTED BY LARA M. CAUDY, APPELLATE DEFENDER FOR THE COMMISSION ON INDIGENT DEFENSE. MY APPELLATE CASE No. 2021-000863. I AM CURRENTLY HOUSED AT RIDGELAND CORRECTIONAL INSTITUTION WHICH IS SEVERELY RESTRICTIVE IN ITS MOVEMENTS OF INMATES AND ITS RESOURCES THAT ARE AVAILABLE FOR LEGAL RESEARCH ARE DRASTICALLY INADEQUATE. IN YOUR LETTER INFORMING OF MY RIGHTS TO FILE PRO SE, I WAS MADE AWARE OF THE PROSCRIBED 45 DAY TIME-LIMIT AFFIXED TO THIS PROCESS THAT IS SAID TO BEGIN ON THE DATE OF THE LETTER WHICH WAS DATED MARCH 3, 2022. INEPPUCABLY, THIS LETTER AT ISSUE WAS "DELIVERED" TO ME ON MARCH 24, 2022 AS CAN BE EVIDENCED BY MAILROOM LEGAL LEDGER.
