

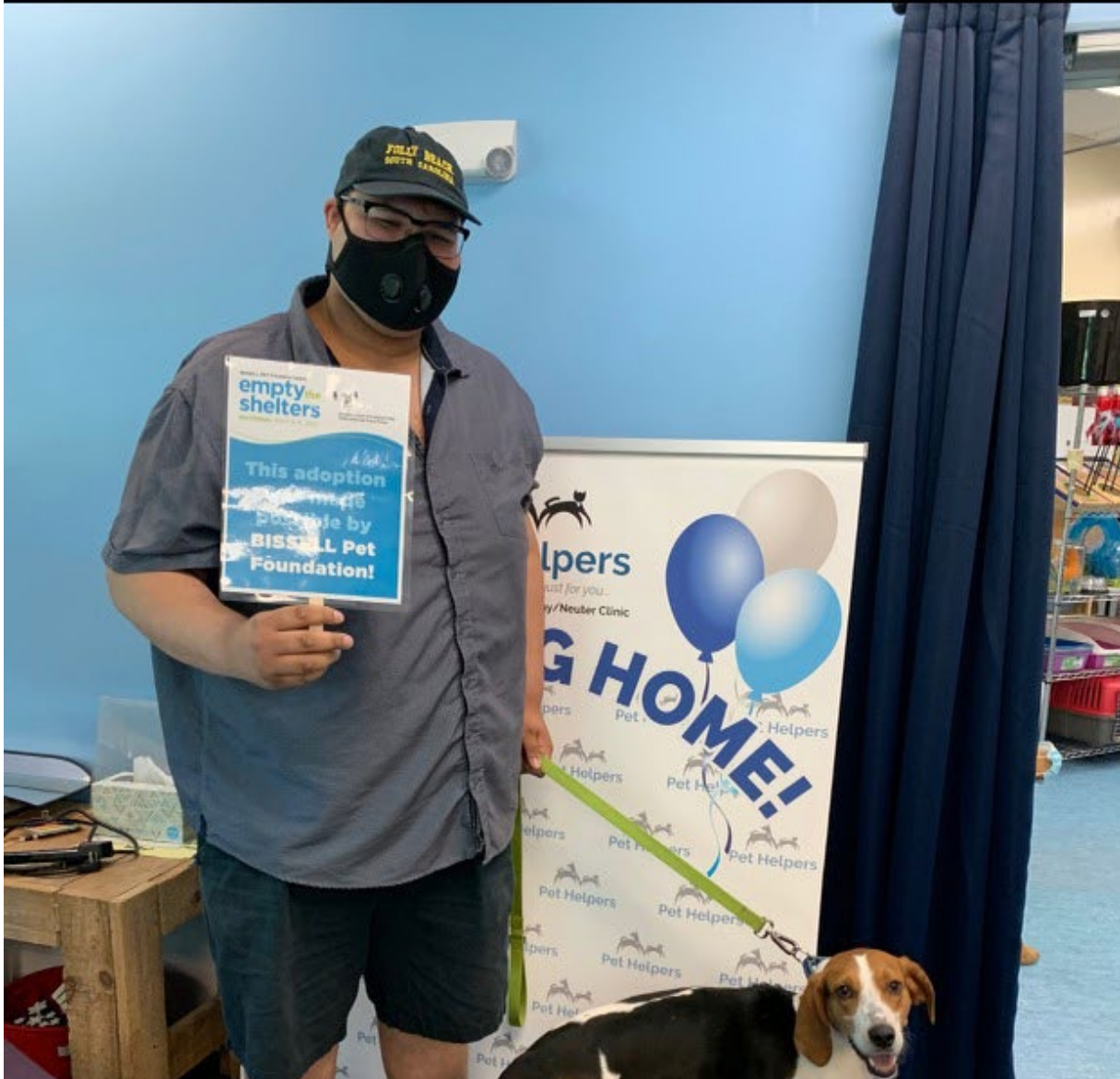
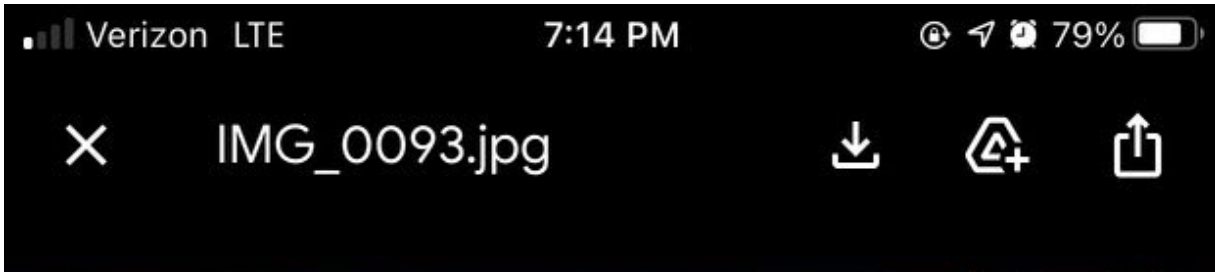

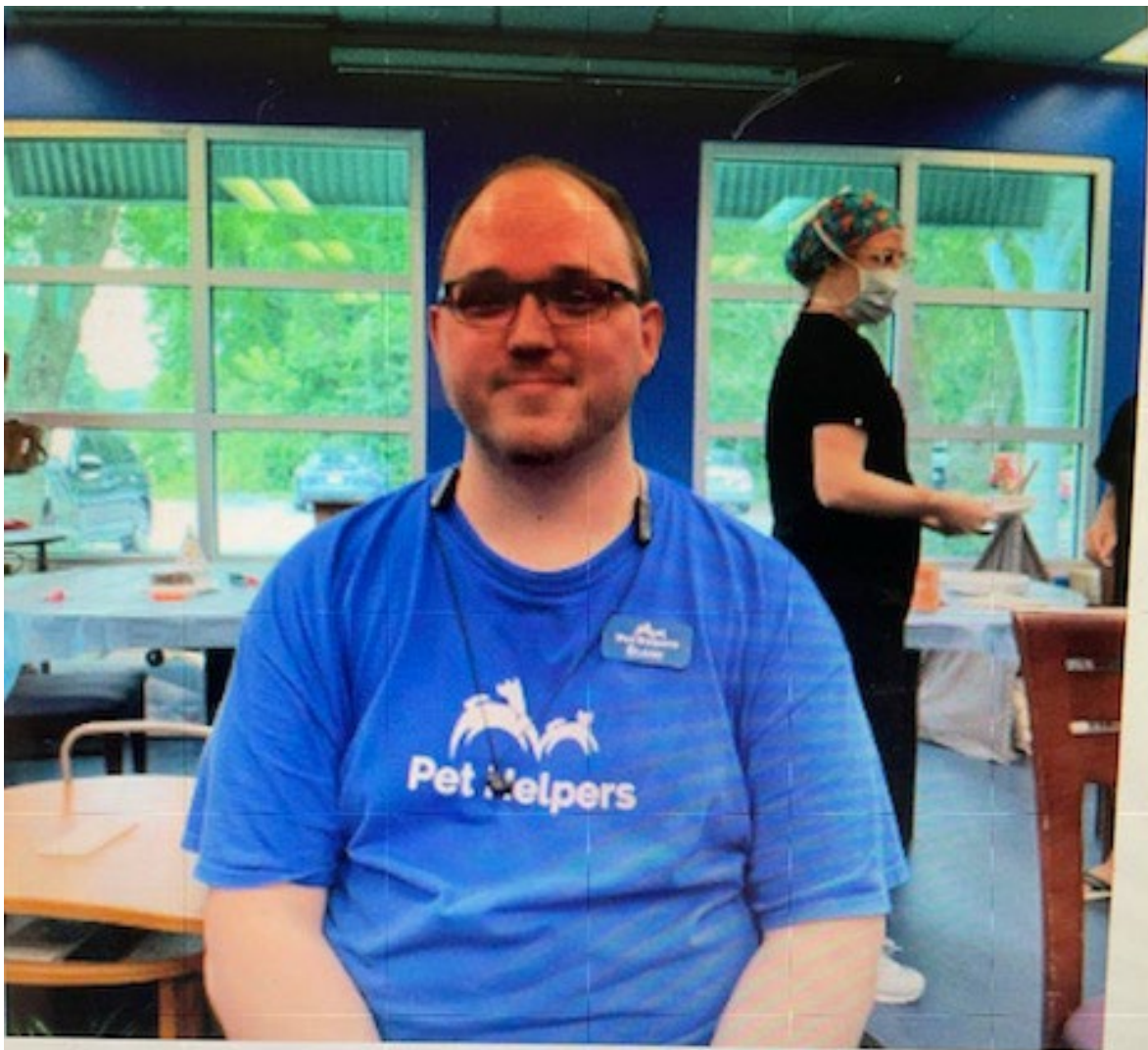

The evidence of Pet Helpers fraud is the unredacted adoption submission that has not been

made available to the court, the pictures of the "adoption" on May 8, 2021 and the fabricated "Happy Ending Update" (Toby is still at the Pet Helpers shelter and doesn't look happy at all). Melissa Susko is certified to euthanize and has been involved in the deaths of at least two dogs (Cody and Dixie) that were not aggressive or medically untreatable according to a previous employee that spoke to me. Ms. Susko tried to get me arrested for trespassing using two of her employees to try and lure me on to the property. You lied in court and on court documents that I had trespassed and threatened Pet Helpers employees in order to obtain the restraining orders against me. You tried to use the Discovery Requests to occupy all my time so I couldn't defend myself from Pet Helpers' fraudulent and malicious lawsuit. The Court of Common Pleas has not allowed me to present evidence or defend myself in the hearings, but has consistently granted your requests without investigation and is therefore suspect of "abuse of discretion". The Appellate Court dismissed my appeal without considering the rule pursuant to the appeal and my "Petition for Rehearing" is currently active and is one of the many reasons that a hearing for your Motion for a Partial Summary Judgement should not have been scheduled.

In the past, The Court of Common Pleas, Dennis Markley, dismissed my case without being heard against Debra Walker who was in possession of my stolen vehicle and attempted to gain ownership by fraudulently using a mechanics lean through the magistrate court of David Coker in North Charleston. My neighbor, Antonio B. Harris is a meth dealer and has been protected by law enforcement agencies and the Dorchester County Magistrate Court so do not try to imply in your memorandum supporting the partial summary judgement that corruption of law enforcement and the courts is impossible when I have abundant first-hand knowledge of it.

Toby was not returned to me because Pet Helpers wanted to make money on him, not because they were concerned that I had too many dogs. The surrender form I signed did not give them permission to euthanize him, and I'm sure that was the original plan after they used him as a marketing tool, but couldn't carry out because of my public protest. The adoption was staged by Ms.Susko, John Blaine , Katie Leasure and other employees at Ms.Suskos orders and was probably not the first time they staged a fake adoption in order to solicit donations falsely based on placement. They subjected Toby and me to suffering for financial gain which is their primary goal and then denied that abandonment causes any distress to pets in answer to my Requests to Admit.

You're guilty of "fraud upon the court" and your lawsuit is a fraudulent and malicious attempt to cover up criminal behavior by your client.

My last comment to your nonsense memorandum is that people who are not willing or able to pay a reasonable fee for a vaccinated, altered canine, will probably not be able or willing to pay future expenses associated with owning a dog. Pet Helpers is not interested in the welfare of pets or their caretakers. I am totally convinced because of the way they treated Toby and me after the surrender and continue through the brutality of their lawsuit, but soon the public will know the truth about you, Pet Helpers and the Courts and the criminal nature of what is occurring.
