


Dear Ms. Manley:

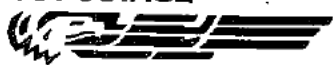
