THIS MATTER came before the Court for a status conference on August 20, 2019 to address various matters related to expenditures made by Respondent John Edward Vergeldt (“Mr. Vergeldt”) immediately prior to his resignation as Successor Trustee of the John Vergeldt, Jr. Revocable Living Trust dated September 27, 1978 (“Trustee”) and the process by which Petitioner Vicki Lynn Vergeldt, Individually, and as Successor Trustee of the John Vergeldt, Jr. Revocable Living Trust dated September 27, 1978 (“Petitioner”), may make expenditures from, by, and/or on behalf of the Trust during the remainder of this litigation.

As an initial matter, the status conference was attended by Taylor A. Peace, Esq., attorney for Petitioner, and Daniel J. Ballou, Esq., Mr. Vergeldt’s former counsel. Mr. Ballou was relieved as Mr. Vergeldt’s counsel by Order Granting Motion to Withdraw as Counsel (“Order Granting Withdrawal”) on August 16, 2019; however, due to the scheduling of the status conference relative to the entry of the of the Order Granting Withdrawal, Mr. Vergeldt, who is now proceeding *pro se*, did not participate. Prior to the entry of this Order, Mr. Vergeldt was informed of the substance of the matters discussed at the status conference, has been given an opportunity to respond and/or

object to the Court's instructions, and his comments, revisions, and/or objections to this Order have been incorporated herein and/or noted by the Court.

Based on the documents submitted to the Court prior to the status conference and representations of counsel and/or the parties, it appears that Mr. Vergeldt resigned as Successor Trustee of the Trust on or about, March 29, 2019, and, approximately one (1) month later, withdrew Eight Thousand Nine Hundred Six and 74/100 (\$8,906.74) Dollars from the Trust's bank account with the intent of using same to pay his attorney's fees and costs. Mr. Ballou has been holding the funds in trust pending the Court's guidance on how to deal with same. It also appears Mr. Vergeldt did not seek the Petitioner's consent prior to withdrawing the funds nor did he make application to the Court for its approval of the withdrawal. These actions appear to be in violation of the framework set forth in the Order for Summary Judgment issued by the Honorable S. Jackson Kimball, Master in Equity for York County, on May 21, 2018. Mr. Ballou has returned the funds to Petitioner so that Mr. Vergeldt can make application to the Court for a disbursement in compliance with the Order for Summary Judgment if he so wishes.

Regarding the restrictions in the Order for Summary Judgment relative to Mr. Vergeldt's resignation and Petitioner's appointment as Successor Trustee, the Court is of the opinion that the same or similar restrictions should be imposed upon Petitioner during the course of this litigation to insure that the limited Trust funds that are available are managed, protected, and expended in a reasonable manner that is consistent with the Trust and in accordance with South Carolina law.

NOW THEREFORE, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED

that:

1. Petitioner is enjoined from making an expenditure of Trust funds without the consent of the Mr. Vergeldt or an order of this Court;
2. To obtain Mr. Vergeldt's consent, Petitioner's counsel shall submit to Mr. Vergeldt the amount of the proposed expenditure, an explanation of the necessity of the expenditure, and a bill, estimate, invoice or other documentation evidencing the need for the expenditure. Mr. Vergeldt shall have five business days to file with the Court any written objection and/or opposition to the proposed expenditure. If Mr. Vergeldt fails or refuses to file an objection/or opposition within ten business days of service, he will be deemed to have consented to the expenditure and agreed that the same is reasonable and necessary.
3. Petitioner may deposit Trust funds into the Trust's accounts without prior consent by Respondent or the Court's approval.
4. These conditions shall continue until modified or removed by subsequent order of this Court.

FOR A FIRST DEFENSE

Jackson Kimball, Master in Equity for York County, filed on August 31, 2015 in C/A No. 2014-CP-46-1956 ("Order") as it speaks for itself and represents the best evidence thereof.

5. To the extent Paragraphs 15, 16, 17, and 18 require a response from Petitioner, the same are denied and strict proof demanded thereof to the extent they are inconsistent with the allegations of the Petition and Amended Petition.

6. Paragraph 19 requires no response from Petitioner.

7. To the extent Paragraphs 20 and 21 require a response from Petitioner, the same are denied and strict proof demanded thereof to the extent they are inconsistent with the allegations of the Petition and Amended Petition.

8. To the extent Paragraph 22 requires a response from Petitioner, she craves reference to the Order as its terms speak for itself and represent the best evidence thereof. To the extent Paragraph 22 is inconsistent with the terms of the Order, the Petition and the Amended Petition, the same is denied and strict proof demanded thereof.

9. Paragraph 23 requires no response from Petitioner.

10. To the extent Paragraphs 24, 25, 26, and 27 require a response from Petitioner, the same are denied and strict proof demanded thereof to the extent they are inconsistent with the Petition and Amended Petition.

11. Paragraphs 28 and 29 require no response from Petitioner.

12. To the extent Paragraph 30 requires a response from Petitioner, it is denied and strict proof demanded thereof to the extent the same is inconsistent with the Petition and Amended Petition.

13. Paragraph 31 requires no response from Petitioner.

14. To the extent Paragraph 32 requires a response from Petitioner, it 32 is denied and strict proof demanded thereof to the extent the same is inconsistent with the Petition and Amended Petition.

15. Paragraph 33 requires no response from Petitioner.

16. To the extent Paragraph 34 requires a response from Petitioner, Paragraph 34 is denied and strict proof demanded thereof to the extent the same is inconsistent with the Petition and Amended Petition.

17. Paragraph 35 requires no response from Petitioner.

18. Paragraph 36 contains references to the Order, and Petitioner craves reference to the same as it speaks for itself and represents the best evidence thereof. To the extent Paragraph 36 is inconsistent with the Order, Petition, or the Amended Petition, the same is denied and strict proof demanded thereof.

19. Paragraphs 37, 38, and 39 require no response from Petitioner.

20. To the extent Paragraph 40 requires a response from Petitioner, the same is denied and strict proof demanded thereof to the extent it is inconsistent with the Petition and Amended Petition.

21. Paragraphs 41, 42, 43, and 44 require no response from Petitioner.

22. To the extent Paragraph 45 requires a response from Petitioner, the same is denied and strict proof demanded thereof to the extent it is inconsistent with the Petition and Amended

Petition.

23. Paragraphs 46, 47, 48, 49, 50, 51, 52, 53, 54, 55, 56, 57, and 58 require no response or reply from Petitioner.

24. To the extent Paragraph 59 requires a response from Petitioner, it is denied and strict proof demanded thereof to the extent the it is inconsistent with the Petition and Amended Petition.

25. Paragraphs 60, 61, 62, 63, 64, 65, 66, 67, 68, 69, 70, 71, and 72 require no response or reply from Petitioner.

26. To the extent Paragraph 73 requires a response from Petitioner, it is denied and strict proof demanded thereof to the extent the same is inconsistent with the Petition and Amended Petition.

27. Paragraphs 74, 75, 76, and 77 require no response from Petitioner.

28. To the extent Paragraph 78 requires a response from Petitioner, it is denied and strict proof demanded hereof to the extent the same is inconsistent with the Petition and Amended Petition.

29. Paragraphs 79, 80, 81, 82, 83, 84, 85, 86, 87, 88, 89, 90, 91 require no response from Petitioner.

30. To the extent Paragraph 92 requires a response from Petitioner, it is denied and strict proof demanded thereof to the extent the same is inconsistent with the Petition and Amended Petition.

31. Paragraphs 93, 94, 95, and 96 require no response from Petitioner.

32. Replying to Respondent's **WHEREFORE** Paragraph and all of its subparts, the same are denied and strict proof demanded thereof.

FOR A SECOND DEFENSE

33. Petitioner incorporates the previous allegations of this responsive pleading as if repeated herein verbatim to the extent the same are consistent with the Petition and Amended Petition.

34. The Response fails to state a cause of action against Petitioner for which relief can be granted, and the same should be dismissed pursuant to Rule 12(b)(6), SCRCP.

FOR A THIRD DEFENSE

35. Petitioner incorporates the previous allegations of this responsive pleading as if repeated herein verbatim and to the extent the same are consistent with the Petition and Amended Petitioner.

36. Respondent's claims against Petitioner, if any, are barred by his own bad faith and unclean hands.

FOR A FOURTH DEFENSE

37. Petitioner incorporates the previous allegations of this responsive pleading as if repeated herein verbatim to the extent the same are consistent with the Petition and Amended Petitioner.

39. Respondent's claims against Petitioner, if any, are barred by doctrines of waiver, estoppel, and/or equitable estoppel.

FOR A FIFTH DEFENSE

40. Petitioner incorporates the previous allegations of this responsive pleading as if repeated herein verbatim to the extent the same are consistent with the Petition and Amended Petition.

41. Petitioner alleges that the injuries and damages alleged by Respondent, which

Petitioner expressly denies, were due and caused by the sole, intervening, and superseding negligence, willfulness, wantonness and recklessness of the Respondent over whom the Petitioner had no control so as to bar the Respondent's claims, if any.

WHEREFORE, having fully responded to the Response, Petitioner prays that this Court dismiss the same, grant her the relief requested in the Amended Petition, and for such other and further relief as this Court deems just and proper.

The income and assets of John Vergeldt, Jr. or the John Vergeldt, Jr. Trust dated September 27, 1978, were investigated and resulted in a review of twelve accounts: eleven depository accounts in financial institution and one retirement account administered through First Allmerica. In addition transactions were noted which involved another account at First Citizens Bank Account #9209 titled in the names of John E Vergeldt or Terry Shaw Vergeldt. Also John Vergeldt's personal income tax returns for 2010, 2011, 2012, and 2013 were reviewed, as were the Vergeldt Trust fiduciary income tax returns for 2014, 2015, and 2016.

Statements for each account were available from January 2008 for those accounts open before that date or from the date of the opening of the account if the account had been opened after January 2008. From the statements, check registers were prepared for each account so that transactions could be reviewed. Apparently no registers were prepared contemporaneously by the Trustee.

There were frequent transfers from one account to another. Some transfers could be confirmed by descriptions on the statements. In other cases, the dates and amounts matched on two accounts, so these were identified on the check registers as a transfer between those accounts.

A list of funds deposited and disposition of withdrawals which could not be identified are listed on Exhibit A of this Report. Copies of deposits and checks are only available for the last seven years. Therefore, the transactions occurring more than seven years ago cannot be conclusively resolved unless the Trustee can provide documentation of other information about the source or application of the funds. In addition, the scope of authority for the LST did not provide access to the First Citizen Account #9209, which would probably be helpful in resolving some of the items.

1. What has been accounted for:

- a. All Social Security benefits from January 2008 through date of death were deposited into accounts of John Vergeldt, Jr. (Credit Union ONE) or the Vergeldt Trust (First Citizens Account #4009).
- b. All retirement benefits paid by First Allmerica from January 2008 through date of death were deposited into Credit Union ONE account of John Vergeldt, Jr.
- c. All withdrawals from the Old Mutual Financial/Fidelity and Guaranty Life annuity from January 2008 through date of death were deposited into accounts of John Vergeldt, Jr. (Credit Union ONE) or the Vergeldt Trust (First Citizens Account #4009). The death benefit was deposited into First Citizens Account #4009; book value of annuity was reduced by surrender fees due under the fixed income

contract as evidenced by correspondence and the Form 1099 from Fidelity and Guaranty Life (the successor to Old Mutual Financial).

- d. Statements or other records of all the accounts at the financial institutions reported to have paid interest or dividends on Schedule B of the various income tax returns were found, and check registers have been prepared and included in the Trust Accounting.
 - e. The proceeds from the sale of the Berwyn Road house were deposited into the Credit Union ONE account via a wire transfer.
 - f. John Vergeldt, Jr.'s purchase of 800 shares of Biowatch Medical, Inc. is of no value as the company filed for Chapter 7 bankruptcy in February 2015 and was discharged from bankruptcy in March 2017.
 - g. Of the \$168,000 purchase of the condo unit in Henry Ford Village was financed partially through a non-interest bearing promissory note in the amount of \$151,200. This note was paid off by a check from the Credit Union ONE account. The two refunds from Henry Ford Village were deposited into First Citizens Account # 4009 and First Citizens Account # 1409, respectively.
 - h. For the Duke Energy Premier Notes account, \$49,983 was deposited and \$506.00 in interest was earned. This account was titled as John Vergeldt, Jr. and John E. Vergeldt JT Ten. Of this, \$40,000 was later deposited into the Edward Jones account on a Duke Energy check signed by John E. Vergeldt. A second deposit of \$10,400 was made into the First Citizens account #1409. This leaves \$89 as not accounted for.
 - i. For the Yadkin Valley Bank money market account, \$75,430.14 was deposited by transfers from accounts of John Vergeldt, Jr. or the Vergeldt trust. Several other small deposits were made and interest in the amount of \$286.00 was earned. From this account, a deposit of \$10,000.00 was made into the First Citizen Account # 4009. The remaining balance of \$66,379.52 was deposited into First Citizens Account #4009.
2. What items or issues are not resolved:
- a. Through the use of First Citizens Account #9209, the Trustee co-mingled the funds of John Vergeldt, Jr. with the Trustee's funds. A number of deposits into the various accounts were from Account #9209, and there were numerous withdrawals from accounts of John Vergeldt, Jr. into Account #9202. (See Tab 4 in the Trust Accounting Notebook.)
 - b. The source of a number of deposits into accounts of John Vergeldt, Jr. or the Vergeldt Trust could not be identified. These are listed on Exhibit A of this

report. Likewise, the application of some funds withdrawn could not be identified from the records available. These are also listed on Exhibit A of this report.

- c. Numerous checks were written to "Cash" from First Citizens Account #4009 beginning in early 2012 and continuing through August 2013. These checks for which copies were available are listed on Exhibit B of this report, which was updated up receipt of check copies from First Citizens Bank.
- d. No file copies of income tax returns from 2008 and 2009 were provided to the LST.
- e. It appears that John Vergeldt, Jr., would have had to make some cash payment in January 2008 when he purchased the condominium at Henry Ford Village, as the purchase price was \$168,000 and the promissory note was for \$151,200. However, there is no check or other debit in the amount of \$16-17,000 from an account open at that time.
- f. The \$50,000 Fifth Third Bank certificate of deposit was funded by a check from the Credit Union ONE account, and interest accrued in the amount of \$7,969.87 at the maturity date of September 22, 2011. The certificate of deposit was titled as John Vergeldt or John E. Vergeldt. Within two months of the maturity date a deposit of \$15,000 was made into the Duke Energy PremierNotes account; a withdrawal in this amount was not found in any of the other Vergeldt Trust accounts so a presumption would be that this deposit was funds from the maturing certificate of deposit. However, the balance of \$42,969.87 has not been accounting for.
- g. A debit card for First Citizens Account #4009 was used on a regular basis from the opening of the account in July 2010 through July 2013, when John Vergeldt, Jr., passed away. It was not unusual for there to be fifteen to twenty purchases each month, and it was not possible to determine whether any or all of these purchases were for the benefit of John Vergeldt, Jr.
