COUNT ONE- CRIMINAL SEXUAL CONDUCT WITH A MINOR FIRST DEGREE

CDR: 0385 16-03-0655(A)(1)


That Jerney Cnard Pearce did in Florence County, State of South Carolina, between the dates of March 1, 2019, and March 3, 2019, willfully and unlawfully commit the crime of Criminal Sexual Conduct with a Minor in the First Degree by engaging in sexual battery with a minor who is less than eleven (11) years of age, to wit: a minor female, whose date of birth is 10/19/2010, in violation of Section 16-3-655(A)(1), S. C. Code of Laws, 1976, as amended.
