

Dear Madam Clerk:

Pursuant to SCACR 208 (b)(7), the Respondents hereby call the Court's attention to new case law from the S.C. Supreme Court that has developed subsequent to the parties' filing their Briefs in the instant case. The new case is Keene v. CNA Holdings, Op. No. 28052 (S.C. Sup. Ct. filed August 11, 2021)(Howard Adv. Sh. No. 27 at p. 50) (Petition for Rehearing DENIED April 5, 2022). Respondents submit that this case significantly impacts the "statutory employment" issue presented in this worker's compensation matter. Moreover, both parties have prominently cited the Court of Appeals' decision in Keene in their respective briefs to this Court, including Appellant's plea for the deferral of a decision by this Court pending the Supreme Court's decision. (See Appellant's Brief p. 8.). By copy of this letter to counsel for the Appellants we are confirming this notice of Supplemental Citations to the Court under SCACR 208.
