1. The petition for writ of certiorari and accompanying appendix in this case are due to be served and filed today, April 27, 2022, having been extended by one prior order of this Court.



Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Raphael L. Pontoo v. The State with the Supreme Court on April 11, 2022. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Joseph Decoriyus Burton with the Court of Appeals on April 6, 2022. Counsel filed the initial brief of appellant and designation of matter in the case of In the Matter of the Care and Treatment of James L. Williford with the Court of Appeals on April 6, 2022. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Kareem Stevenson with the Court of Appeals on March 28, 2022. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Nikeen D'Aundre Johnson with the Court of Appeals on March 21, 2022. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Corey Rashad Brown with the Court of Appeals on March 11, 2022. Counsel filed the petition for writ of certiorari to the Court of Appeals in the case of The State v. Jeffery James Williams with the Supreme Court on March 9, 2022.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


