So With Respondents Designation of Matter list they submitted on 8/27/21 is in Amended Record on Appeal Why would they need to file a motion to Supplement Record on Appeal instead of filing their final Brief?

Respondents Motion for Extension to file final Brief dated 04/20/2022, #3, states Respondents Final Brief was docketed as due on 04/20/2022, instead of them submitting their final Brief they file a motion for another extension, the first extension was granted on 02/16/2022. Looking at the dates that I filed my record on Appeal (9/22/21) Respondents filed a motion to strike (9/24/21). I filed Record on Appeal (12/02/21) Respondents filed a motion to Consolidate, Extension. I filed my final Brief (12/23/2021) Respondents filed a motion to Dismiss (01/04/2022). I Re-Submitted Record on Appeal (02/28/2022) Respondents filed a motion to Supplement Record (04/10/22). 04/20/2022, Respondents final Brief was due they file a motion for Extension to file final Brief (04/20/2022)

Respondents have stated they had NOT received Amended Record on Appeal, Their Designation of Matter is missing from Current Record on Appeal. And now a motion for extension to file final Brief.

And #4 of Motion for Extension to file final Brief states they cant submit a final Brief until their motion to Supplement the Record on Appeal has been decided when all that was required was for Respondents to do their due diligence by fact checking Amended Record on Appeal and all the others I'd filed.
