

Please allow this letter to serve as my response to the Court's letter dated April 20<sup>th</sup>, 2022. The transcript has been requested and correspondence from the court reporter is attached. I filed a notice of appearance in this case on March 29<sup>th</sup>, 2022. Prior to doing so, my office contacted the South Carolina Commission on Indigent Defense for a copy of the file. There's no caption, but if this is the case of the State of South Carolina vs. Talliferro Butler, which was held on December 13th and 14<sup>th</sup> in Orangeburg county, the transcript was ordered by the South Carolina Commission on Indigent Defense on January 7, 2022. The transcript request was withdrawn by them on March 29, 2022.

I was not informed that Mr. Butler had new counsel and that was why the initial request was withdrawn by SCCID.

I've estimated the transcript to be approximately 280 pages in length. At our current page rate of \$4.25 per page, the estimated cost would be \$1,190.00. This is just an estimate and the final page number may be different.

Please let me know if you would like to officially order the transcript and I will put it in line for transcription.
