MOTION FOR AN EXTENSION TO SERVE AND FILE
THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Amy Berridge respectfully requests a **final thirty (30) day extension, until June 6, 2022**, in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Amy Berridge respectfully submits that extraordinary circumstances

exist which warrant the granting of an additional extension of time. Given the number of extensions previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.

Counsel testified in the Lexington County Court of General Sessions for a Post-Conviction Relief hearing in the case of Ronald Michaux v. The State on April 12, 2022. Counsel filed the Motion to Hold in Abeyance in the case of Theodore Jerry Bolick v. The State with the Court of Appeals on March 28, 2022. Counsel filed the Anders Brief of Appellant in the case of The State v. George Riley Dreher with the Court of Appeals on March 16, 2022. Counsel filed the Anders Brief of Appellant in the case of The State v. Craig Corey Cooper with the Court of Appeals on March 7, 2022. Counsel appeared before the Court of Appeals for oral argument in the case of The State v. Phillip Lowery on March 8, 2022.

4. Counsel makes this request in good faith and not for purpose of delay.

5. On April 28, 2022, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through May 31, 2022.

WHEREFORE, the undersigned counsel would respectfully request a **final thirty (30) day extension until June 6, 2022**, in which to serve and file the Petition for Writ of Certiorari




