**MOTION TO CORRECT DEFICIENCIES IN RECORD ON APPEAL AND


The Appellant has prepared a five (5) volume Record on Appeal in this matter. Upon preparing his Final Brief, the Respondent has become aware of several deficiencies or clerical errors in the Record on Appeal that has prevented him from being able to properly prepare his brief. The Respondent's Final Brief is due on May 9, 2022. The deficiencies in the Record on Appeal that have been observed by Respondent is as follows:

1. The Index indicates that the Notice of Motion to Amend Judgment filed October 13, 2020, contains attachments, however the attachments are not contained in the Record on Appeal.
2. The Index indicates that the Plaintiff's Response to Motion to Amend filed November 3, 2020, contains attachments, however the attachments are not contained in the Record on Appeal.
3. There is a clerical error as the date of the Transcript Motion Hearing was February 25, 2020, not November 5, 2020, as indicated in the Record on Appeal.

Respondent respectfully requests that this Court issue an Order requiring the Appellant to correct the deficiencies contained in the Record on Appeal.

Respondent further respectfully requests an extension of time to file his Final Brief as his brief is currently due on May 9, 2022, and he is unable to comply with this deadline due to the deficiencies in the Record on Appeal.




