NOTICE OF APPEAL


Appellant, Emitt R. Gunnells, appeals the Order of the Appellate Panel of the South Carolina Workers' Compensation Commission dated May 9th, 2022, on the following grounds:

1. THE COMMISSION ERRED AS A MATTER OF FACT AND CONCLUSION OF LAW IN FINDING THAT THE CLAIMANT'S "LIFETIME INDEMNITY AWARD ENDS ON OR ABOUT DECEMBER 31ST, 2032; ACCORDING TO THE MORTALITY OR LIFE EXPECTANCY TABLES".
2. THE COMMISSION ERRED AS A MATTER OF FACT AND CONCLUSION OF LAW IN FINDING THAT THE DEFENDANTS MAY CEASE PAYMENT OF BENEFITS OF CLAIMANT'S LIFETIME AWARD ON OR ABOUT DECEMBER 1ST, 2023 IN ORDER TO RECOUP A CREDIT.


