I am sure this is the last and final letter I am sending your office. I just want to put on record as well as all other documentations on record in your office. as I have sent your office a Notarized copy of letters and documentations that were presented about the "Strategy Decision" - that you didn't object to in brief that I went along with her decision to ask for a continuance, which is a "lie" and how I am going to prove it, is not thru your office or the Supreme courts office. So here's my same story as outlined in my "Proof" PCR Application all three (3) Video Visit, I requested from the jail April 14th, June 10th, and July 23, 2016. transcripts from D. Ashley Pennington's office thru the Freedom of Informations Act, that "ACT" was Violated. See letter from Pennington, who got angry at me for requesting the truth, which is at each and every Video Visit that is recorded and proof. "Solar" states you are very lucky to have that 1 year Rec. You have essentially maxed-out, I told her at those Video Visits instead of me going to prison with the year on a turn around, ask the judge to let me stay here at the jail to finish

the year. ("See Video Visit"). So I can complete the DAODAS drug and alcohol program, because I had been in the (12) week program for 6 weeks, and I had 6 weeks left. "I never told that bitch to go less than a year or continue, cause she has told me I'd served (4) months you have essentially maxed out. "Solar" has no proof, I have proof of her "lie" at the P.C.R. hearing March 1st, 2018 just by simply going to the ("Video Visits") records I requested a transcript through the F.O.I.A. and the "ACT" will be concluded in evidence upon my complaint to the Federal Magistrate judge, Once the court hear's what she said on all my Video Visit in 2016. Then the courts will see her

change in representation between June 10th, 2016 Visit Essentially maxed out and written in the bottom right hand corner of her notes, inclosed, again for the record, July 23rd, 2016. Then everything changed July 23rd, 2016 court date changed to go before Kristi Harrington by use of "CLOUT" also known as "Political Influence". That Barch Bitch did this, when she came to prison and saw me then immediately departed the prison Nov. 1, 2017. Documented to Pennington". She sent me to a sex offender program Shields Ministries, when I was sentenced to Turning Leaf Aug 11th, 2014. Not a Sex offender Program.

My life was threatened as a predator and I left that program. by way of witnesses who helped me move out. I have

filed also to the Charleston County Sheriff's Dept, Al Cannon, two notarized letters complaint with no response, against the defendants: "Solar", "Holmes" and 9th Judicial circuit Public Defender D. Ashley Pennington and General Session Court and judge. Also enclosed already in your records is a letter to the S.C. Bar pertaining to the Numerous complaints on these defendants March 24th, 2018 about misconduct in office and Violating my Constitutional Civil rights to Due Process, 5th, 6th, 8th, and 14th Amendments. See letter enclosed for the record as well.

Again the Sheriff's dept. Knows as well as I know that "SOLAR" work with Probation and Programs, Probation "Holmes" and "Bareh" conspired in this "CLOUT" to get me in front of "Harrington" to get me full revocation and the judge stated at the reconsideration she knew about the recommendation, They all withheld leniency recommended by same agency. "Harrington" knowing she had the power to present the recommendation and deny it, instead she too withheld Due Process, and denied it at the reconsideration hearing the same day. But know this is a "Political Influence" (CLOUT) by the defendants. I hope Karma brings them the same luck I had when my attorney "Solar" said I was lucky to have that recommendation, what comes around goes around. I'm going to CCNV to conduct an investigation, Date line 01/20/20. One more thing how many Burglaries cases where the defendant had been in the dwelling for over 1 1/2 hours. Judicial has entirely committed to use Post ex-facto against me when they were all minor or many years ago. Will also be presented in (1983) complaint, I think the Governor and Attorney General will be added to the listed above defendants, et. al. I'm glad to hear that things are moving in a positive direction for you and wonderful to hear that you are now attending church and you are saved. Dear Ms. Solar,

I recieved your most recent letter concerning my case and would like to address some things that I have concerns about. In your letter you said you were shocked that Judge Harrington did not go along with the Hearing officers recommendation. Well at the hearing when the judge asked was there a recommendation, both you and the hearing officer advised her that there was not an offer when in fact at the neutral hearing does to determine whether my matter would be sent back before the Court, the hearing officer did in fact make a recommendation. As all in my probation warrant it has stated that I had violated my probation by committing another burglary where the fact that was not the case, if you look into the matter you will discover that the burglary mentioned happened prior to me being placed on probation. I have been studying these things that are necessary when the Judge is hearing a motion of reconsideration and have discovered that in most instances that it is required that there be a change in circumstances. Like when Hearing Officer B stated I was in Turning Leaf Release program when the program hadn't started when I was sentenced 8-11-2014, I was sent to Shields Ministries

Program, in which I completed, and went to Mr. Ashley's Friday night groups as well, (3) I didn't owe restitution as stipulated on Judge Harrington's sentencing sheet July 26th, 2016, (4) The court date was changed without documentation, I had the documentation signed by agent Albach and myself on May 17th, 2016. (5) This was my first violation and the recommendation was 1 year continue, (6) Also since I finally got the Aug 11th, 2014 sentencing sheet by Judge Nicholson (117). It was court ordered to Blood test me for mental health medicines, Bi-Polar and Post Traumatic Stress Syndrome I was never tested.

These are the strongest issues which led Judge Harrington to impose full revocation, the other issues were minor, and the failure to appear where from being in jail for the Burg^{red} for 4 months and the other failure to appear were from being in the I.O.P. institution of Psychiatry ward at MUSC, Trident, Palmetto and Saint Frances during the 3 months, as well as being hospitalized just as many times in MUSC Trident, Rogers St. Frances, for Alcohol Poisoning, and an assault head trauma and hit by car both in March 2016, I feel that the issues that I have presented you with can provide a change in the judges decision,



Joanie,

Here is the situation with Mr. Stone:

He pled guilty to Burg second violent in 2014 and received 15 years suspended to 5 years of probation. He reported for over 1 year but ended up violating his probation bc he has mental and physical problems and was homeless and he stopped reporting. He was also in and out of the hospital for detox (alcohol). Probation was recommending a 1 year revocation and then for his probation to be continued. He was arrested on the violation on March 20, 2016 and our court date was July 26, 2016. Judge Harrington revoked Allen in full. 15 years.

Documented Directive for 8-8-2016 stated 7-23-2016 had something to do on 8-8-16, Video Visit
From what I can recall, I spoke to Mr. Allen mostly about trying to get him continued on probation. I told him that the state was recommending a 1 year revocation. I NEVER promise that the judges will follow recommendations. I do offer that some judges are more likely to follow recs than others. I may have told him that, as far as I knew, Harrington followed recs. (And she did until then!)...she revoked the majority of my clients in full that day. Of course, I felt that the sentence was extremely excessive and intended to file a motion to reconsider. I had told Harrington everything I knew about that case that I thought might help but I was going to file the motion anyways. Ashley might remember the case bc I asked him after the hearing whether he could give me any insight as to how Allen had done at the Shield Ministries Friday night meetings...i needed something to say at the hearing to reconsider. Ashley told me that Allen was not one that participated too much and that he could not say much to help.

Lie
During the time immediately after the hearing, I asked Renee to file the motion to reconsider the sentence. Amanda was out on vacation and I was about to go on vacation as well. Renee had printed out the motion and told me that the motion was in my box. I went on vacation assuming that the motion had been filed with another attorney's signature as is often done. When I came back from vacation, I discovered that the motion had not been filed and it was obviously beyond the 10 days allowed to file. *write letter within 10 days withheld records presented at PCR March 2018*

Shortly after that, I spoke to Kescia Holmes, Court probation supervisor, who agreed with me that the sentence was excessive in her opinion. I asked her if she would be in agreement to have Harrington waive the 10 days to file the motion and she agreed. I spoke to Judge Harrington in court a few days later and she told me to email her law clerk with the details. I sent her an email on August 25.

Some time had passed and I had not heard back from the law clerk. I emailed her again and a while later she left me a voicemail asking me to send her a copy of the motion. I asked Amanda to file the motion and send it to Elizabeth. The motion was filed on Oct 12. Amanda sent a copy to Elizabeth on Oct 21 along with an email asking her to schedule a hearing.

Meanwhile, Mr. Stone has written Ashley a letter regarding his anger at how I handled his case. He also suggests that he should not have pled guilty in the first place and that his convictions are bc of the PD's office and not the police or the Solicitor's office. He is not clear in his letter as to what he is asking us to do. I believe he wants us to get him in front of

a judge for a hearing but he does not want our office to represent him. He says he wants a pro bono lawyer for his appeal.

Note: He says in his letter that he filed his own motion for a hearing directly after the violation hearing. I may be able to use that as a way to get him into court on a motion to reconsider. I have no idea what he actually filed if that is, in fact, true.
