


NOTICE OF APPEAL





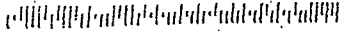
