

NOTICE OF APPEAL

On Friday, May 13, 2022, Jason Peele (Peele) pled guilty to Voluntary Manslaughter, and guilty under North Carolina v. Alford, 400 U.S. 25, 91 S.Ct. 160 (1970) to Armed Robbery. The Honorable Edgar Dickson sentenced Peele to concurrent terms of twenty-seven (27) years imprisonment with credit for 608 days time-served. Peele now appeals his guilty pleas and sentences.
