

Counsel filed the Final Brief of Appellant and the Final Reply Brief of Appellant in the case of The State v. Gary M. Wirtz with the Court of Appeals on March 28, 2022. Counsel filed the Johnson Petition for Writ of Certiorari in the case of Bruce M. Richardson v. The State with the Supreme Court on March 16, 2022. Counsel filed the Final Brief of Appellant in the case of James Winston Almond v. The State with the Court of Appeals on March 9, 2022.

4. Counsel makes this request in good faith and not for purpose of delay. On April 28, 2022, opposing counsel, the Office of the Attorney General, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through May 31, 2022.

WHEREFORE, the undersigned counsel would respectfully request a **final thirty (30) day extension until June 24, 2022**, in which to serve and file the Petition for Writ of Certiorari and Appendix in this case based upon the above exigent circumstances. 
pending a ruling on this motion.
