MOTION FOR AN EXTENSION TO SERVE AND FILE  
THE PETITION FOR WRIT OF CERTIORARI  
AND APPENDIX

Counsel for Tamarquis Antwain Wingate respectfully requests a **final thirty (30) day extension, from May 27, 2022 until June 27, 2022**, in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Tamarquis Antwain Wingate respectfully submits that extraordinary

circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Raphael L. Pontoo v. The State with this Court on April 11, 2022. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Joseph Decoriyus Burton with the Court of Appeals on April 6, 2022. Counsel filed the initial brief of appellant and designation of matter in the case of In the Matter of the Care and Treatment of James L. Williford with the Court of Appeals on April 6, 2022.

4. Counsel makes this request in good faith and not for purpose of delay.


5. On April 28, 2022, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through May 31, 2022.
