3. The parties are in the process of finalizing the settlement documents. Once those documents are fully executed, the parties will file a motion to dismiss both appeals currently pending before the Court.


4. During the interim, the parties would respectfully request that the Court stay both proceedings for thirty days so that the settlement can be fully consummated.
