**MOTION FOR THIRD EXTENSION OF TIME WITHIN WHICH

I.

Along with that and other responsibilities in the office, the undersigned counsel has also prepared for and given a presentation as part of a recorded continuing legal education seminar for South Carolina magistrate judges on May 20, 2022.

III.


